Decentralization Grant Program - To provide funding to non-profit organizations interested in promoting and developing arts and cultural projects. Grants were awarded to 23 qualified organizations for 25 projects.

Various projects undertaken during the fiscal year includes: concerts and festivals, a dance workshop, fiddlers' picnic, summer reading programs, theatrical workshops, musicals and plays, an arts in the library program, storytelling, and an arts showcase.

4b (Code:) (Expenses \$ **7,823** including grants of \$) (Revenue \$ **9,300**)

Folk Arts Program - To promote an appreciation in traditional folk arts by providing funding for various folk arts programs including round and square dancing. The folk arts program is continually researching and documenting local arts and traditions including music, dance, material arts, verbal lore, foodways, ethnic arts, and others.

4c (Code:) (Expenses \$ **7,344** including grants of \$ **3,405**) (Revenue \$ **7,401**)

Arts In Education Program - To provide funding to promote an awareness of the performing arts in the local school systems. The program pairs teachers with teaching artists to work together with students in the classroom integrating art into the curriculum. Four local school districts were served with an artist-in-residence. The number of youth benefitting from the program totaled approximately 4,000.

Projects undertaken during the fiscal year included the following: creating sculptures, poetry, writing projects, and story creation through the use of theatre and dramatics.

The Livingston Arts Center is the community arts center and home to the New Deal Gallery, a space devoted to the display of Livingston County's collection of Work Progress Administration paintings; Apartment One, a gallery for local artists and collections; classroom and workshop areas; and a gift shop featuring the work of local artists.

Total program revenue was \$36,222 and program service expenses amounted to \$16,757.

The Substance Abuse Education Program is administered by Livingston Arts on behalf of the Council on Alcoholism and Substance Abuse of Livingston County. It is an improvisational troupe made up of high school performers whom travels to area schools to use improvisational theatre to teach about good decision-making habits in regards to substance abuse. The training and leadership of this group is provided by a local professional actress/director who is contracted by Livingston Arts and also includes summer theatre at recreation programs and friend-raiser movie nights. Total program revenue was \$1,662 and program service expenses amounted to \$3,054.

High School Scholarship Fund is awarded by Livingston Arts to participants in our annual scholastic art show. Scholarships are for \$200 and are awarded to seniors planning to attend college and major in the visual arts. They must be recommended by their art teacher. Judges of the scholastic show view the work of the applicants and decide on who receives the scholarships. Total program revenue was \$2,139 and program

The Livingston Arts Center is the community arts center and home to the New Deal Gallery, a space devoted to the display of Livingston County's collection of Work Progress Administration paintings; Apartment One, a gallery for local artists and collections; classroom and workshop areas; and a gift shop featuring the work of local artists.

Total program revenue was \$36,222 and program service expenses amounted to \$16,757.

The Substance Abuse Education Program is administered by Livingston Arts on behalf of the Council on Alcoholism and Substance Abuse of Livingston County. It is an improvisational troupe made up of high school performers whom travels to area schools to use improvisational theatre to teach about good decision-making habits in regards to substance abuse. The training and leadership of this group is provided by a local professional actress/director who is contracted by Livingston Arts and also includes summer theatre at recreation programs and friend-raiser movie nights. Total program revenue was \$1,662 and program service expenses amounted to \$3,054.

High School Scholarship Fund is awarded by Livingston Arts to participants in our annual scholastic art show. Scholarships are for \$200 and are awarded to seniors planning to attend college and major in the visual arts. They must be recommended by their art teacher. Judges of the scholastic show view the work of the applicants and decide on who receives the scholarships. Total program revenue was \$2,139 and program
